any right to question, contest, oppose and/or challenge the Bank's execution of any such payments or disbursements either before they are made, at the time of payment, or subsequent thereto. The Bank is authorised to pay on simple demand any sum or sums claimed under the Guarantee.				
A We irrevocably and unconditionally authorise the Bank to place immediately a block on our account for an amount equal to the amount of the Guarantee issued at our request, and in				
addition the Bank will have the right at any time and without further notice to debit our account with all payments which the Bank may make in connection with the Guarantee; at its sole				
discretion and for whatever reason. In addition to this, the Bank is also authorized to debit our account with the full amount of the Guarantee now or at any time prior to its return to the Bank for cancellation, and to hold such amount as security to cover our liability towards the Bank in connection with the Guarantee and until our liability in respect thereof, actual or				
contingent, is cancelled to the Bank's satisfaction. The Bank is authorised to apply the amount so held, in whole or in part, for any claim the Bank may have against us in accordance with the terms of this undertaking and we will pay to the Bank on its first demand, the remaining part, if any, of any such claim it may have against us, or at its option, the Bank may debit our

understood that Bank's commission will be charged on all amounts, inclusive of principal, profit, interest, fees etc. that are guaranteed by the Bank.				
We hereby acknowledge and agree that commission on the Guarantee is due and charged in advance for the initial validity period of the Guarantee or for any period agreed at the discretion of the Bank save for cases where amounts that are guaranteed by the Bank may only be calculated at later stage, whereby additional commission will be debited to our account				
when possible, at the Banl<'s discretion. Any delay in debiting such commission shall not constitute a waiver. This period will not be in any case less than three months unless exceptionally
